V. Presentations

2. Received a presentation from Board Chair Wayne Schurter regarding the presentation of the 2021 Outstanding Senior Citizen Award that was presented to Jeannie Lewis on Tuesday, September 6, 2022, at City Hall.

- 37 People came to see her
- 5 Board Members attended
- 5 Proclamations were read that day and Jeannie's was first, and the largest
- Wayne previously went to the Mayor's office and talked to the Mayor's assistant, Beverly Trollinger, to get the proclamation written. Together they put together a proclamation of Jeannie's accomplishments
- Mayor Hughson read the entire proclamation
- Jeannie was presented with the Volunteer Award at the ceremony
- Wayne stated that he would like to have a proclamation for every volunteer award winner in the future.

VI. Action Items

03. Discuss and consider approval, by motion, the criteria for a Senior Resource Directory listing.

- Chair Wayne Schurter asked for a review of the Senior Resource Directory.
- Vice Chair Diane Eure reminded the board that they decided at the last meeting that they would vote on the criteria for the Directory at this meeting.
- Staff Liaison Nick Riali told the Board that they could decide on what criteria they would follow for a listing in the Senior Resource Directory as long as it was allowed by the City and followed the City's guidelines. (The City's guidelines were printed and given to each board member.) He also showed the board what was currently entered in the Senior Resource Directory by using the Smart Board at the Activity Center and let them know all website links on the Directory were working.

- Chair Wayne Schurter suggested that someone needs to be attached to the website and possibly have 2 board members to review any listing requests and let them decide if it should be brought to the full board for approval or rejected.
- David Ross added that keeping the list to government and non-profit agencies and organizations would keep the list smaller and more manageable.
- Diane Eure mentioned that governmental wasn't listed specifically on the City's guideline printout and she questioned if the board should follow what San Marcos allows, does the board need to do anything, or if the Board wants to change what San Marcos allows, add more or less, then does the Board need to do anything? She then stated that the other option would be to not have a formal structure but do what Wayne suggested and have 2 board members to review any listing requests and bring it back to the board.
- Ron stated that there should be 2 gatekeepers and that they bring the information to the entire board for a decision. Diane stated that there probably wouldn't be a huge influx of stuff to deal with. She also stated that after the Senior Expo, they could review the vendors to see if any meet the criteria that the board might want to add to the directory.
- A motion was made by Diane Eure, to limit the additions to the Senior Resource Directory Module to non for profits and government entities. It was seconded by David Ross. The motion carried by the following vote:

- The board also discussed about how to get volunteers to help, either through Sororities or Texas State departments.


